Technical Bid

Specifications. The Existing Basketball court is required to be upgraded by providing and laying of ITF Classified imported material (Refkim made in Europe) 5 Layer System Synthetic Acrylic for Basketball Court as specified below:-

- (a) One layer of concrete Primer.
- (b) One layer of Resurfacer/
- (c) One layer of cushion rubber
- (d) Two layers top coat
- (e) White Lime marking paint.
- (f) Basketball Poles movable 6" square pipe projection 2*20 Acrylic Board 20 mm Malaysia with dunking ring (3 spring).
- (e) <u>Eligibility criteria</u>: MES, PWD, CPWD enlisted and other govt departments enlisted Contractors/ Professionals of Basket Ball/ Sports Courts having proper Registration/CST/GST Nos with experience of construction with synthetic surface. The bidder should have completed at least one such work with any one of the above department or any other recognized Institute. Experience certificate to this effect will be obtained from the department/Institute and attached to the tender documents with the amount of such work completed in last five years.

(g) Commercial Bid

- (i) Prices of the items should be inclusive of GST.
- (ii) Cost of materia, transportation, installation and labour charges etc complete should be mentioned including warranty period. Warranty for manufacturing defects would be for one year.
- 5. It may please be noted that Technical Bid and Commercial Bid given above need to be submitted in separate sealed envelope. Technical and Commercial Bid found in single envelope will be liable to be rejected.
- 6. Bids in sealed cover are invited for construction of outdoor Basketball Court with Synthetic surface from the firms having proper Registration/TIN/CST/GST No. Please super scribe (type of bid) for Up Gradation of Basketball court ", RFP number i.e 1011/Constr/APSU and date of opening of the bids i.e. **26 Apr 2019** on the sealed cover to avoid the bid being declared invalid.
- 7. (a) Last date for submission of bids by **1500 hr on 25 Apr 2019.**The Sealed bids should be deposited/ reach by the due date and time. The responsibility to ensure this lies with the bidder. Bids received beyond the time and date given above shall be rejected.
 - (b) Manner of depositing the bids: Sealed bids should be either dropped in the Quotation Box marked as Quotation box, APS, Udhampur or sent by registered post at the address given above so as to reach by the due date and time. No responsibility will be taken for postal delay or non delivery/ non receipt of bid documents. Bids sent by FAX or e-mail will not be considered (unless the latter has been specifically called for by these modes due to urgency).

- (c) Time and date for opening of bids: **26 Apr 2019 at 1100 hrs** at Main office, APS Udhampur. (if due to any exigency, the due date for opening of the bids is declared closed holiday, the bids will be opened on the next working day at the same time or on any other day/time, as intimated by the buyer).
- (d) **Location of the Tender Box**: Reception of APS Sr Wing, Udhampur. Only those bids that are found in the quotation box will be opened. Bids dropped in the wrong quotation box will be rendered invalid.
- (e) **Earnest Money Deposit**: Bidders are required to submit Earnest Money Deposit (EMD) @ 5% of quoted/tendered amount along with their bids. The EMD may be submitted in the form of Account Payee Draft, fixed Deposit Receipt, Banker's Cheque of Bank Guarantee from any of the public sector banks or a private sector bank authorized to conduct government business.
- (h) Bids received without EMD will be rejected.
