
**CALL FOR QUOTATIONS/TENDERS: RENOVATION OF TOILETS IN TAGORE
BLOCK AT APS SR WING**

Sir,

1. Bids are invited for the under mentioned items of work to be carried out for renovation of toilets in Tagore Block at APS Sr Wing Udhampur:-

Technical Bid:

- (a) Dismantling work of floor, walls, tiling GF, FF.
- (b) Plastering and curing complete.
- (c) Supply and fixing of glazed tiles (wall tiles and floor tiles). Wall tiling will be carried out up to six feet height
- (d) Supply and fixing of new Sanitary fitting items.
- (e) Painting, Primer. etc
- (f) Removal of waste material.

Eligibility criteria

- (a) MES, PWD, CPWD enlisted and other govt Departments enlisted Contractorshaving experience of construction works. The bidder should have completed at least one such work (construction work) with any one of the above department. Experience certificate to this effect will be obtained from the department and attached to the tender documents with the amount of such work completed in last five years.
- (b) Bids received without experience certificate will be rejected.

Commercial Bid:

- (a) Prices of the items should be inclusive of GST.
- (b) Cost of material, transportation, application and labour charges etc complete should be mentioned.

2. It may please be noted that Technical Bid and Commercial Bid given above need to be submitted in separate sealed envelope. Technical and Commercial Bid found in single envelope will liable to be rejected.

3. It may also be noted that the toilets requiring renovation be inspected by the vendors before quoting the rates.

4. Bids in sealed cover are invited for renovation of toilets in Tagore Block from the firms having proper Registration/TIN/CST/GST No. Please super scribe "Quotation for Repair of Parapet wall", RFP number i.e 1011/Constr/APSU and date of opening of the bids i.e. **15 Oct 2018** on the sealed cover to avoid the bid being declared invalid.

5. (a) Last date for submission of bids by **1700 hr on 14 Oct 2018**. The Sealed bids should be deposited/ reach by the due date and time. The responsibility to ensure this lies with the bidder. Bids received beyond the time and date given above shall be rejected.
- (b) Manner of depositing the bids: Sealed bids should be either dropped in the Quotation Box marked as Quotation box, APS, Udhampur or sent by registered post at the address given above so as to reach by the due date and time. No responsibility will be taken for postal delay or non delivery/ non receipt of bid documents. Bids sent by FAX or e-mail will not be considered (unless the latter has been specifically called for by these modes due to urgency).
- (c) Time and date for opening of bids: **15 Oct 2018 at 1200 hrs** at Main office, APS Udhampur. (if due to any exigency, the due date for opening of the bids is declared closed holiday, the bids will be opened on the next working day at the same time or on any other day/time, as intimated by the buyer).
- (d) Location of the Tender Box: Reception of APS Sr Wing, Udhampur. Only those bids that are found in the quotation box will be opened. Bids dropped in the wrong quotation box will be rendered invalid.
- (e) Earnest Money Deposit: Bidders are required to submit Earnest Money Deposit (EMD) @ 5% of quoted/tendered amount along with their bids. The EMD may be submitted in the form of Account Payee Draft, fixed Deposit Receipt, Banker's Cheque of Bank Guarantee from any of the public sector banks or a private sector bank authorized to conduct government business.
- (f) Bids received without EMD will be rejected.
- (g) It may also be noted that bids received without quoting rates for particular project or part thereof advertised above will be rejected.
