Bids in sealed cover are invited for Computer Chairs from the vendors having proper Registration/TIN/CST/GST No. Please super scribe "_____ (type of bid) for Computer Chairs ", RFP number i.e 1058/APSU and date of opening of the bids i.e. **30 Apr 2019** on the sealed cover to avoid the bid being declared invalid.

4. (a) Last date for submission of bids by **1700 hr on 29 Apr 2019**. The Sealed bids should be deposited/ reach by the due date and time. The responsibility to ensure this lies with the bidder. Bids received beyond the time and date given above shall be rejected.

(b) Manner of depositing the bids: Sealed bids should be either dropped in the Quotation Box marked as Quotation box, APS, Udhamapur or sent by registered post at the address given above so as to reach by the due date and time. No responsibility will be taken for postal delay or non delivery/ non receipt of bid documents. Bids sent by FAX or e-mail will not be considered (unless the latter has been specifically called for by these modes due to urgency).
