Quotation/Bid with Bank Draft of earnest money for Rs. 25,000/- each can be submitted by Registered Post at the School's address OR could be physically dropped in the Quotation Box placed at APS Sr Wing Udhampur latest by 23 May 2023 in sealed envelope duly super-scribed as BIDS FOR AUCTION OF SCHOOL BUS of Army Public School, Udhampur. The tender will be opened on 26 May 2023 at 1100 hours at Army Public School, Udhampur. Bidders will be present at Army Public School, Udhampur on 26 May 2023 at 1045 hours.
- 3. The disposal of vehicle shall be strictly on "AS IS WHERE IS AND WHATEVER IS BASIS" and no guarantee or certificate of its worthiness or quality will be given by the school. Bidders need to submit earnest money for Rs. 25,000/- each along with bid. The earnest money can be deposited by Bank Draft/Banker's Cheque in favour of "Army Public School Udhampur, payable at Udhampur". The Bank Draft/Banker's Cheque should be attached with the quoted bid, failing which the bids will not be considered at all. If the highest Bidder/ successful Bidder fails to deposit the sale price within the prescribed time limit, his earnest money will be forfeited. - 4. EMD amount is payable by means of DD/Banker's Cheque in favour of "Army Public School Udhampur, payable at Udhampur" (payment by cash/cheque shall not be accepted). Offers received without EMD amount shall not be considered at all by this institution.
- 5. The successful bidder will be required to deposit the total bid amount by means of DD/ Banker's Cheque in favour of "Army Public School, Udhampur, payable at Udhampur" within seven working days after receiving letter from the School in this regard.
- 6. EMD of the successful bidder(s) will be released only after realization of sale proceeds and transfer of ownership of vehicle. EMD of the bidders who fail to honour the bid in prescribed time limit shall stand forfeited. No representation in this regard shall be entertained by this department. EMD amount will not be adjusted in the sale amount accepted by School. EMD of successful bidder(s) shall be released only after successful completion of the sale process.

- 7. The delivery of the sold vehicle will be arranged only after the successful bidder submits documentary evidence in support of residential status (Ration Card/Voters identity Card/Aadhar Card/ Passport in case of individual and Registration Certificate in case of firms etc.
- 8. The sold vehicle will be removed by the successful bidder(s) by depositing the money at their own expenses. No assistance/ transportation will be provided by the School. Permission to take out the disposed vehicles from School's premises will be allowed only on working days.
- 9. The successful bidder will also be responsible for getting the Registration Certificate of the vehicle transferred in his name at his own cost expeditiously. The Bank will not be responsible for any lapse on his part in this regard. Sale letter will be executed in favour of the Successful Bidder on depositing the entire sale consideration. The successful bidder will also be responsible for getting the Registration Certificate of the vehicle transferred in his name at his own cost expeditiously in the concerned RTO. The School will not be responsible for any lapse on his part in this regard.
- 10. EMD of the firms rescinding their offer, withdrawing or abrogating after submitting the bid shall stand forfeited. Decision of the School shall be final in this regard.
- 11. The School reserve the right to reject all or any tender in whole or part without assigning any reasons thereof.
- 12. EMD of unsuccessful tenders shall be returned within two weeks of the award of contract to successful party.
- 13. The bidder is required to reveal his full name/ name of the authorized signatory of the firm/name of father, full postal address, telephone number and mobile number.
- 14. Disputes, if any, shall be subject to jurisdiction in the Court of Udhampur only.
- 15. If the highest quoting firms fail to honor the bid, the contract will be cancelled and its EMD will be forfeited.
- 16. Tendering forms should be signed in ink by the authorized signatory only. Photocopy or unsigned or not signed by authorized signatory shall be rejected.
